School Bus - Terms and Conditions

- 1. I hereby agree to use the services of the bus for the whole academic year.
- 2. I understand that there will be **no reduction/discount of fees** for medical or personal absences (e.g., overseas trip) from School.
- 3. Parents/guardians must provide one full term's notice should they wish to withdraw their child/ren from the bus. Failure to provide one full term notice will result in charges for the following term. The one full term notice will NOT be considered if:
 - a) Withdrawal notice is given in January, prior to the start of Term 1; in this case, parents are liable to pay term 1 bus fees only.
 - b) Withdrawal notice is given when the term has started; in this case, parents are liable to pay bus fees for the current and following term.

Payment is made over four terms and will be as follows:

- Term 1 bus fee due date: Friday of the 2nd week of Term 1 of the current year
- Term 2 bus fees due date: Friday of the 2nd week of Term 2 of the current year
- Term 3 bus fees due date: Friday of the 2nd week of Term 3 of the current year
- Term 4 bus fees due date: Friday of the 2nd week of Term 4 of the current year

If you unable to pay your bus fee on time, please contact us immediately and the college will try to work with you to make a payment arrangement acceptable by the college.

- 4. This bus contract lasts for one full calendar year. By the 3rd week of Term 4 every year, parents will need to complete a new form if they wish for their child(ren) to continue to use the school bus service for the following year. The college reserves the right to accept or reject the application for the following year and is under no obligation to provide an explanation.
- 5. The fee differs depending on the bus route and there will be no sibling or health care card discount.
- 6. Working in coordination with Bus Company, the School does its best to provide reliable and timely service. However due to unforeseen circumstance, 'pick-up and drop-off time could vary from time to time. Students must be ready a few minutes prior to their usual pick-up time. As each driver has a bus schedule time to follow, the bus will wait for a maximum of thirty seconds for those students who are not ready and if students are left behind due to being late, parents will be required to find alternative transport.
- 7. Any change to the pickup/drop off address <u>must</u> be requested in writing to the college and must be approved by both the college and the bus company prior to any change.
- 8. Any communication through the bus driver regarding the bus service <u>must</u> be avoided and all communication <u>must</u> be directed to the School Administration Office. The Bus Company will contact parents in January to advise the pick-up time.
- 9. The terms of this agreement are subject to the School bus policy, the College reserves the right to review and change the terms at any time.
- 10. Please be aware that the location students are picked up and dropped off might not always be from in front of the address provided. Buses may sometimes be located on the corner or few houses down.
- 11. To ensure the safety of students and the bus drivers, parents/students must agree on the following bus rules:
 - Students must show respect to the bus driver at all times and follow instructions
 - Students must not throw objects to each other on the bus
 - Students must not stand up or move from the seats whilst the bus is moving
 - Students should not push each other when getting off the bus
 - Students must always wear their seat belts
 - Students should be well-behaved on the bus, this includes no swearing, bullying, screaming fighting or distracting the bus driver
 - No eating or drinking on the bus, this includes chewing gum
 Students should not cause damage to the bus, including ripping the seats or graffiti
