Principal's Message



Assalamualaikum warahmatullah wabarakatuh.

Alhamdulillah, we had a great end to Term 2, with all students and staff being able to return to onsite learning for at least the last few weeks of term. This was met with the strict hygiene measures the College implemented to ensure that all students and staff who enter the College abide by the DHHS guidelines to remain safe and to minimise the spread of Covid-19.

Unfortunately, with the increase in positive cases in Victoria over the term 2 break, and the declaration of stage 4 restrictions, the College has once again had to return to distance e-learning.

The Distance E-Learning plans and live Zooms sessions have continued without disruption for all year levels.

I would like to thank our parents, students and staff for the remarkable quality work they are producing in this situation. Parents and students are reminded to take the time to familiarise themselves with the policies uploaded to the parent portal under the tab "Covid-19"

The College welcomed STEM Week in week 2 of Term 3. Primary students were able to view their teachers participating in Science Lab experiments which were streamed online through ClassDojo. It was wonderful to see the teachers dressed up in lab coats performing the experiments and students excitingly following from home. Secondary students were able to participate in virtual incursions such as "The Chemistry Show", "The Maths Show" and "The Liquid Nitrogen Show." Students also participated in the Rubik's Cube challenge and daily maths/science quizzes with prizes posted to students who won.

The College also celebrated Hajj Week during the most blessed 10 days of the year. A number of special programs were organised this year to ensure students remember and reflect on the great meanings of Hajj and its rituals. On Monday, 27 July, both Primary and Secondary students were asked to dress up in their best Islamic outfit, even students participating on Zoom were encouraged to do so. The Islamic Studies department also uploaded several posts for students to benefit from. These included videos and talks about Eid-ul Adha, the history of the Ka'bah and the Prophet's PBUH final sermon.

Every year the College continues to be overwhelmed with new enrolments. Enrolments for 2021 have now closed except for students wanting to enrol for the Year 11 IB Diploma Programme. Unfortunately, due to the number of enrolments received, enrolments for year levels 1 to 6 are closed for 2021 and 2022. 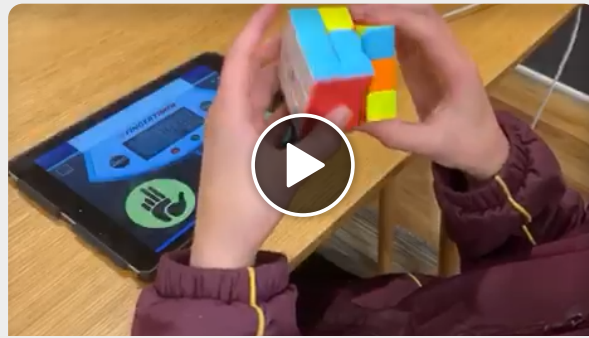

Staying Safe Online

Connecting with family and friends online can be fun and exciting, but it also comes with some risks.

There are a few simple things you can do to keep safe online.

- 1. Think before you accept requests.** Only accept 'friend' requests from people you know in real life. This reduces the chance of getting into an unsafe situation. Do not accept random requests especially if there are no mutual friends.
- 2. Block anyone you've had contact with that exhibits negative or unsafe behaviour.** This stops them from having contact with you and from seeing your profile if they search for you after you block them.
- 3. Think before you upload and share photos.** Post photos that show you and your friends in a positive way. Once it's uploaded, it's no longer private and could be viewed by friends, family, teachers and strangers. Once you post something it becomes available for the world to see – it's not just yours anymore even if it is under your profile.
- 4. Be mindful of what you write to others.** You never know who will read these comments and how they might interpret them. Something that you think is funny could be considered very serious to others.
- 5. Think carefully about sharing links to other sites.** The content could be embarrassing, upsetting or hurtful to others. Also, having an internet security filtering system on your device is a very good tool to filter the content that you are searching for.
- 6. Think about your privacy.** Avoid sharing personal information online that could be misused by someone in real life. Check your privacy settings and make sure your account is secure. Remember, once you post something online about you or your family, it is not yours anymore, because you decided to make it available for the public.
- 7. Seek professional IT advice from an expert.** If you are unsure, just ask those who have the knowledge and those who are impartial. Ask your IT team at school, at work or an expert who is in the industry. You can also seek this knowledge from sources like Google, but make sure those results are authentic and a trusted source of information.

Stay safe and always remember if you don't know something, ask someone who does.

What is the IB Diploma Programme (DP)?

The IB Diploma Programme (DP) is an academically challenging and balanced programme of education with final examinations that prepares students, aged 16 to 19, for success at university and in life beyond. It has been designed to address the intellectual, social, emotional and physical well-being of students. The programme has gained recognition and respect from the world's leading universities. DP students must choose one course from each of five subject groups delivering a breadth of knowledge and understanding in their best language, additional language(s), individuals and societies, the sciences and mathematics. Furthermore, students must also choose either an arts course from the arts group or a second course from one of the other subject groups.

DP courses can be taken at higher level or standard level. At least three and not more than four are taken at higher level (240 teaching hours), while the remaining courses are taken at standard level (150 teaching hours). The DP features three core elements that broaden students' educational experience and challenge them to apply their knowledge and skills.



International Baccalaureate® Learner Profile

The International Baccalaureate® (IB) learner profile describes a broad range of human capacities and responsibilities that go beyond academic success. They imply a commitment to help all members of the school community learn to respect themselves, others and the world around them. Each of the International Baccalaureate's programmes are committed to the development of students according to the IB learner profile.

The IB Diploma Programme Core

Extended Essay (EE)

The extended essay asks students to engage in independent research through an in-depth study of a question relating to one of the DP subjects they are studying. The world studies extended essay option allows students to focus on a topic of global significance which they examine through the lens of at least two DP subjects.

Theory of knowledge (TOK)

TOK develops a coherent approach to learning that unifies the academic disciplines. In this course on critical thinking, students inquire into the nature of knowing and deepen their understanding of knowledge as a human construction.

Creativity, activity, service (CAS)

CAS emphasizes helping students to develop their own identities, in accordance with the ethical principles embodied in the IB mission statement and the IB learner profile. CAS complements a challenging academic programme in a holistic way, providing opportunities for self-determination, collaboration, accomplishment and enjoyment. It involves students in a range of activities alongside their academic studies throughout the DP. The three strands of CAS are creativity (exploring and extending ideas leading to an original or interpretive product or performance), activity (physical exertion contributing to a healthy lifestyle) and service (collaborative and reciprocal engagement with the community in response to an authentic need).

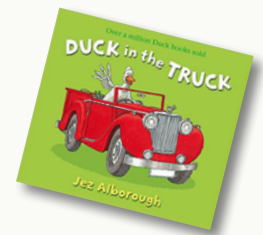

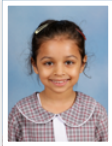

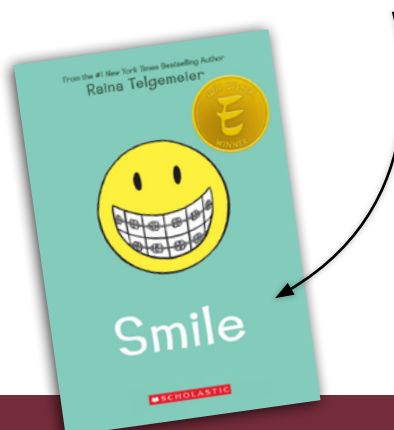

What are eMemberships?

eMemberships allow students to access Wyndham City Libraries' online books, audiobooks, study help services, educational games and movie streaming for free. We will soon have a range of online programs for you to join in.

How do eMemberships work?

Once your child has completed the sign-up process, their membership number and password will provide access to the Library's online resources. This eMembership will be valid for one year.

When will my child receive an eMembership?

The school will assist students in signing up online for eMemberships, Wyndham City Library staff will be providing step by step guidelines showing you how to sign up and use our online resources.

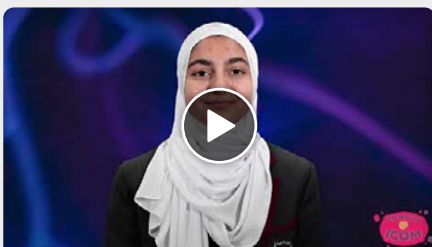

Introduction to Virtual STEM Week 2020

Year 3 STEM Lesson

The Year 3 Department had their Year 3's complete a science experiment to teach students about the importance of hand washing. As part of the STEM Week activities, the Year 3 students conducted this experiment over Zoom. The experiment sparked a lot of interest, and with bread in hand, students were eager to begin.

They carefully followed steps outlined by their homeroom teacher.

First, students hypothesised that mould would grow faster on bread touched with unwashed hands in comparison to bread touched with washed hands.

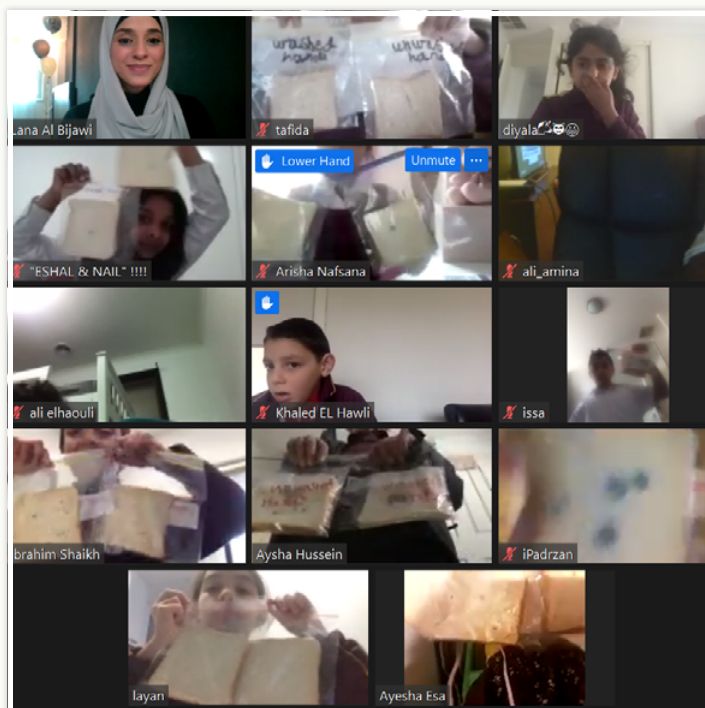
Next, Year 3's touched a slice of bread with unwashed hands. Then they placed the bread into a zip lock bag and labelled it 'unwashed'. Students repeated this process, after washing their hands with soap. Then they placed the bread into a Ziploc bag and labelled it 'washed'.

Students observed the bread over two weeks and recorded their results. They enjoyed sharing their findings with their peers.

Year 3's were fully immersed in the learning process: "What's our next experiment?" Year 3C inquired.

2020 Non-Government School Census collection notice

The Australian Government provides funding to Australian schools under the *Australian Education Act 2013* (AE Act). The AE Act and the associated *Australian Education Regulation 2013* (the AE Regulation) require that a school authority provides the Australian Government with certain information about the school, its staff, and student body to ensure the school's funding is properly calculated and appropriately managed. This information is collected by the Department of Education, Skills and Employment (the department) on behalf of the Australian Government.

What information does the department collect in the Non-Government Schools Census?

Any personal information collected is protected by law, including the *Privacy Act 1988*, and will be handled in accordance with that Act, the AE Act and the AE Regulation.

The authorities that operate schools, such as a Catholic Education Office or an independent school authority, will provide basic information about the school to the Australian Government. This includes its name, address, contact details and years of schooling offered.

The school authority must provide information to the department about the makeup of the school's staff and student body during an annual school census. This is because Australian Government funding varies according to whether students are primary, secondary, receiving distance education, or are overseas students and is calculated to provide additional funding, called 'loadings', for students at educational disadvantage.

The school authority must provide the department with information about the number of staff and students at the school (no names are provided), including the number of:

- teaching and non-teaching staff
- primary and secondary students
- full-time and part-time students
- Aboriginal and Torres Strait Islander staff and students
- students with disability
- students receiving distance education
- boarding students
- overseas students.

The department will also collect the name, position and contact details of the staff member nominated as the primary contact for the annual census.

The authority is required to publish some of this information, and it is also published by the Australian Curriculum Assessment and Reporting Authority (ACARA) on the My School website at www.myschool.edu.au.

There may be circumstances in which a school authority will voluntarily provide personal information about individual students to the department. Where a student has not attended a school during the annual Census Reference Period, but the authority wishes to receive funding for them, the authority will provide the department with information about a student showing they meet funding criteria. The department does not require information that identifies an individual student and asks the authority to censor any documents before providing them. The department will destroy any documents it deems sensitive immediately upon receiving them.

Why is this information collected?

The department collects the information outlined above for the purposes of the AE Act, which include:

- calculation of Australian Government funding
- publishing and providing information about schools to the public.

The department also uses the information for research, statistical analysis, and policy development on school education for the Australian Government.

Aggregated information from the annual school census about the school's student body may also be used to validate data from other collections undertaken by the department, such as the Student Residential Address And Other Information Collection.

Who receives this information?

School authorities provide this information directly to the department. The department may in turn pass the information on to ACARA, state and territory education departments and authorities, the Australian Bureau of Statistics (ABS), and the Productivity Commission. Information passed to ACARA, state and territory education authorities, the ABS, and the Productivity Commission is used by those organisations for their public purposes. For example, the information collected from school authorities under the AE Act forms part of the national statistical collection maintained by the ABS.

From time to time, the department engages contractors to audit or verify school records to ensure that the information a school authority provides to the department on behalf of a school is accurate. The information previously collected by the department may also be passed onto these contractors for this purpose. When carrying out an audit, the contractors may need to access information about individual students from the school's records. This information may be 'personal information' within the meaning given in the *Privacy Act 1988*.

The contractors may pass this information onto officers within the department if there is a discrepancy in the data provided by the school and the school's records and further investigation is required.

The department will also provide the information to other organisations if required or authorised by law to do so. Other than in exceptional circumstances (for example, investigation of fraud relating to overseas students), the department does not disclose any of the personal information collected to overseas recipients.
